Transportation can keep track of miles and schedule timely maintenance; and that the Superintendent emphasize to the school principals that the vans must receive regular maintenance or vans will be centralized.

ITEMS FROM THE GOVERNING BOARD

Mrs. Petri expressed her sadness that Idyllwild and Cottonwood schools fell off the list to apply for Distinguished School status.

Mr. Sanborn indicated he, Mrs. Forst and Mrs. Gosch had a nice visit at Whittier School and with Mr. Swartz, the principal. He stated he saw a school that's in good shape and running very well with good administrative support.

Mr. Sanborn requested to be part of the process in selecting a replacement for Diane Cardinalli at Idyllwild School. Also he indicated that an Idyllwild bus broke down recently and requested that Mr. Beck look into the practice of loading the students from that bus onto another student occupied bus citing safety concerns as there were 3 students to a seat and students standing.

Mr. Peters expressed interest in the old Jacob Wiens site and asked if any classes were empty and what the plans were for the site next year. Dr. Pendley responded that consideration is being given to moving the alternative programs to a site of their own or leaving them there to grow. He indicated that there is some room at that site for growth of the alternative programs and that the extra classrooms would be filled over time if they remain at that site.

Mr. Cook expressed appreciation for the Organization Chart with pictures. He indicated that he would be unable to be at the November 8 special meeting but he would make arrangements for training so as not to slow anyone down. Mr. Cook inquired if board members would have input into the interior design of the Professional Development Center and board room. Mr. Pendley affirmed that the Board would have input.

Mrs. Forst commented that a Valley Watch committee had been formed to inform the community of sexual predators living in the area and that they would be meeting Nov. 16 at 6:30 p.m. at the San Jacinto Valley Wide. The community is invited and a flyer will be distributed to parents in the district.

Mrs. Forst shared that shewent to Valle Vista Elementary School's Harvest Festival last week which lots of people attended and it looked to have been a great fundraising event. On Sunday she went to Idyllwild for the Dartmouth Symphonic Band Concert which she stated was incredible and illustrated the value of continued support of the fine arts programs in the district.

Mrs. Petri inquired if the Valley Watch information was to be distributed valleywide or district-wide. Mrs. Forst said it would be distributed district-wide.

ITEMS BY THE SUPERINTENDENT

Dr. Pendley indicated he would be going to San Francisco on Wednesday to meet with Dale Scott and other superintendent clients to brainstorm about funding possibilities, and then would be in Sacramento at the ACSA conference, therefore out of the district for the next three days.
